Introduction

This website is maintained by the London Legacy Development Corporation ('the Legacy Corporation'). The Legacy Corporation is a mayoral development corporation and a statutory body which is responsible for the long-term planning, development, management and maintenance of Queen Elizabeth Olympic Park.

The Legacy Corporation is committed to protecting your privacy and will process your personal data in accordance with data protection legislation. This Fair Processing Notice describes how personal data is processed, including the collection, management and storage. It also explains your rights and freedoms as a data subject.

The personal data that is collected about you

The personal data which is collected about you is the name and email address you use to register to log-in to the site.

The IP address may also be collected (this is a unique identifier of the computer you are using). This would be used to analyse usage of the site. Please note, it is possible to conceal the IP address of a computer if you do not wish to share it.

Cookies may be used to track use of the site and to understand how users are using the site in order to make improvements. For example, they could show that a user gets to a certain page, but then no further.

How your personal data is used

Your personal data will be used to contact you and to help you engage with the work of UKIDG. Your email could be used to deal with requests, to send you information about the work of UKIDG including events.

The IP address and cookie information could be used to improve the user experience of the website.

Please be assured; your personal data will not be shared or sold to any third parties. It will not be used by the Legacy Corporation to send you unsolicited marketing.

Cookies

Cookies are small pieces of software which help computers communicate with each other. They are generally used to improve the user experience and to provide analytical data such as how many times a particular webpage is visited, or not as the case may be. This sort of analysis can be very useful in understanding what parts of the website are actively used and which parts are not being used. It can really help with the delivery of information and in helping the user find what they are looking for.

Your personal data rights and freedoms

As the user of the website you are a 'data subject' as defined by UK data protection laws. This gives you legal rights and freedoms. For example, it means the Legacy Corporation will only use your personal data for the purpose it was collected for and will keep your personal data secure at all times.

Your rights enable you to ask the Legacy Corporation about what data it holds about you. You also have the right to ask to have your personal data – including your email address – removed at any time. In accordance with your rights, the Legacy Corporation will commit to removing your personal data as soon as it can, once a request has been made.
